Recent Developments in Organic Photovoltaics

By Prof. Alamgir Karim Dept. of Polymer Engineering, U of Akron

Exploitation of solar energy is being explored both nationally and globally, with economic solar technologies being identified by the National Academy of



Engineering (NAE) as one of the 14 Grand Engineering Challenges of the 21st century. It is anticipated that in the future use of organic or polymeric based photovoltaics (PV) will provide solar technologies that are cheap enough to be widely exploited and therefore provide a significant fraction of future energy production needs.



For organic photovoltaics (OPV) technology to meet these challenges, the efficiencies of OPV materials and devices must be enhanced several fold beyond the current ~5% to make these next generation solar cells competitive with current inorganic photovoltaics or hybrid systems. This presentation will review the rapid growth of research in OPVs - starting from fundamental principles to recent developments in new materials, concepts and current challenges.

Biography of Speaker Alamgir Karim

Alamgir Karim received his B.S. in Physics from St. Stephens College, Delhi in 1985 and his PhD. in Physics from Northwestern University, Evanston, Illinois in 1990. He did an internship at IBM Almaden Research Center, San Jose and post-doctoral work at the Department of Chemical Engineering at the University of Minnesota, Minneapolis in 1991.

He is currently Goodyear Chair and Professor at the Department of Polymer Engineering at University of Akron. His group focuses on processing and characterization of functional block copolymer thin films for flexible electronic applications and polymer blend scaffolds for tissue engineering. He was previously Leader of the nanomaterials Group in the Polymers Division at NIST.

He has published over 170 papers in the area of polymer thin films research and is a Fellow of the American Physical Society




