


The Akron Section has enjoyed a successful society year. We offered a full complement of monthly programs for

Bylaws & Policies

Council approved the following previously read and published Bylaw and Policy changes: 7.3.2 pertaining to the number of nominations; 14.7.11 pertaining to the SPE European Board.

Council approved changes to Bylaws 6.2.4 pertaining to Council Membership and 6.2.5 pertaining to Proxies. Since this was a first reading, these changes will be published in *Plastics Engineering* and read again at the next Council meeting for final approval.

General Financial Condition

SPE has run a modest positive balance for the first three months of 2010.

Overall Membership

Overall membership at the end of April is 14,700. Strong recruitment campaigns launched in the fourth quarter of 2009, as well as email acquisition campaigns in the first quarter of 2010, have generated 750 new members for the Society through April. Recruitment efforts to "outside" lists remain a serious challenge. Renewals continue to run on par with last year.

Firelands Section

Has filed with National for Provisional Status due to lack of involvement in their local board. Their request was approved. The Akron section will try to reach out to their members to involve them in the Akron Section Board and Technical Programs.

Plastics Engineering Website

Wiley and Sons, Inc., SPE's publishing partner for *Plastics Engineering* magazine, has introduced a new website for the publication: www.plasticsengineering.org. Fully integrated with www.4spe.org, the Wiley site is a showcase for the more "commercial" content developed by both organizations, including new pages for items such as the Online Technical Library and the Consultants Circle.

SPE Foundation Update

Gail Bristol, Managing Director of the SPE Foundation, reported that the Foundation investment balance was \$1,621,000 as of the end of March 2010. She indicated that the Foundation scholarship program deadline was extended to February 15, and the selection of recipients was still in process; the Plastics Pioneers Association recently renewed their PlastiVanTM grant program through the Foundation; and the Thermoforming Division had reinstituted their Equipment Grant program for educational institutions.



An initiative has been undertaken to develop a set of new directions for the SPE Akron Section with the objectives of revitalization and operational efficiency.
